2. **Project Overview**:

We seek proposals from qualified contractors for the comprehensive renovation of the Tennis Court West. The project entails various specialized layers and coatings as per the specifics outlined in the Bill of Quantities (BOQ).

3. Scope of Work:

The scope of work encompasses the following tasks as delineated in the BOQ:

- 3.1 Preparation of 6-layer Acrylic Synthetic Court 13404 Sqft
- 3.2 Primer Resurface Course (1 Layer):

Providing and laying one coat of Acrylic Resurface blended with approved silica sand to establish a strong bond between the surface and cushion layer.

3.3 Cushion Course (2 Layers):

Providing and laying two coats of Acrylic rubber binder blended with approved rubber Crum for optimal cushioning and durability.

3.4 Filler Course (1 Layer):

Providing and laying one coat of approved filler material for a smooth surface.

3.4 Colour Course (2 Layers):

Providing and laying two coats of Approved Colour with highly weather and ultraviolet resistant finish.

3.5 Lines (Marking):

Providing and laying two coats of heavy-bodied acrylic latex for white striping paint, which covers in one application.

- 4.2 Cost breakdown aligned with the specified work items from the BOQ.
